Amelia (Santomassimo) Hodgkinson Fasig lived in two houses in Baychester:

1935 **2230 Boller Avenue**, living with her son in her parents' house;

1940 **2308 Boller Avenue**, living with her second husband **Charles Fasig** and their family.

Amelia Santomassimo (1907-1985), daughter of Joseph Santomassimo and Susie Plusensky, had two husbands, first George Allen Hodgkinson (1901-1971), whom she married in Manhattan, New York on May 5, 1926. Her second husband was Charles Fasig (1895-1967), whom she married around 1936.

In 1925 **Amelia Santomassimo**, age 18 and single, was living in Manhattan, New York with her parents and siblings.<sup>2</sup>

In 1930, **Amelia Hodgkinson** and her infant **George Edgar Hodgkinson** were living in the Bronx at 429 East 9th Street, in the household of her father **Joseph Santomassimo** and his family<sup>3</sup>. Amelia was just 22 years old and her son was a mere 2 years old (born Nov. 20, 1927). Already Amelia was separated from her husband **George A. Hodgkinson**, who is nowhere to be found.

In 1935 Amelia's parents have moved to 2230 Boller Avenue in Baychester, one block away from where Charles Fasig is living. It is most likely that Amelia is still living with her parents, now in Baychester, and where she most probably met Charles Fasig.<sup>4</sup> Amelia married her neighbor **Charles Fasig** around 1936.

**Charles Fasig** was born on June 30, 1895 in Manhattan, New York, the fourth of seven children of native New Yorker **Henry Fasig** and English immigrant **Mary Wittekind**. His mother died in 1900. His father died a few years later in 1908. By 1924 Charles was living at **2308 Boller Avenue** in Baychester, working as a Collector for the gas company.

By 1940 Amelia has married **Charles Fasig** and is living with him in Baychester, along with her son **George Edgar Hodgkinson**, now age 12, and infant twins **Arthur and Charles Fasig**, one year old. They are living at 2308 Boller Avenue, Baychester, Bronx, New York.<sup>5</sup>

**Amelia (Santomassimo) Fasig** died in 1985 in Wayne County, PA<sup>6</sup> (where her son **George E. Hodgkinson** was living) and is buried in Calvary Cemetery in Queens, New York City, New York. She shares a **Santomassino** (misspelled on gravestone) family gravesite and is buried with her parents **Joseph and Susie**, brother **Arthur**, sister **Lottie Postens**, and husband **Charles Fasig**. <sup>7</sup>

Amelia's first husband, **George Allen Hodgkinson**, who was born in Texas, is found back in Texas, married to **Edna Cleo Zuver**, with a child born on Dec. 18 1928. In 1930 Amelia, his first wife, states she is married, not divorced, and without additional information, it is not known if a divorce ever happened before **George A. Hodgkinson** moved back to Texas. No 1930 census record was found for him in 1930. In 1940, **George A. Hodgkinson** is living with his second wife and two children in Texas.<sup>8</sup> He died in 1971 in Texas.<sup>9</sup>

Amelia's son **George Edgar Hodgkinson**, who was living at 2308 Boller Avenue, Baychester, Bronx, NY in 1940, joined the Navy and spent the next several years in the service of his country. In 1948 he is married and is living at **3301 Baychester Avenue**, Bronx, New York. That is less than one mile from his home in 1940. He and his wife(?) **Lillian Mandel** just had a baby who, in 1948, either died at birth or was stillborn. <sup>10</sup>

**George Edgar Hodgkinson** had a second wife, **Gertrude Vanvorst**, with whom he had four children. George went on to have a third wife, **Sally**, where we find her and George in Florida at the time of George's death in 2001.

Amelia's second husband was Charles Fasig, whom she married around 1936. Charles was born in Manhattan, New York on June 30, 1895. His father **Henry Fasig** was born in New York; his mother **Mary Wittenkind** was born in England. Charles was one of seven children. His mother died in 1900 leaving six young children.

When he became of age **Charles Fasig** joined the Coast Guard. After his military service we find him living as a boarder in 1925 at **2308 Boller Avenue** in Baychester, Bronx, New York. By 1930 he now owns the house he was a boarder in, and is single.

By 1940 **Charles Fasig** has married **Amelia (Santomassimo) Hodgkinson** and has taken in her son **George Edgar Hodgkinson**, and has also fathered twin boys, **Arthur and Charles Fasig**, who were one year old. In 1942 Charles completed the WW II Draft Registration, still living at **2308 Boller Avenue**. He was a Collector for the gas company.

Charles Fasig died in November 1967 and is buried in wife Amelia's family's large gravesite. Amelia joined him 18 years later. They are in Third Calvary Cemetery, Queens, New York.

#### **FASIG CHILDREN**

Amelia and Charles Fasig had twin sons: Arthur W. Fasig and Charles Henry Fasig, Jr., born August 17, 1938. **Arthur William Fasig** was married, no children, and died on January 23, 2009<sup>17</sup>. His last place of residence was New Fairfield, Fairfield, Connecticut. **Charles Henry Fasig, Jr.** was married; had three children; and died on December 25, 2013<sup>18</sup> in Lake Ariel, Wayne, Pennsylvania.
